To achieve vision the college has conducted Guest Lectures and Awareness programme.

- 1. On 4th February, 2021 the **"World Cancer Day"** was observed by the N.S.S Unit & Youth Red Cross Wing of the college. Dr. Kumar Kantimath, Associate Professor, D.G.M. Ayurvedic Medical College, Gadag who was the guest speaker and spoke on that symptoms of the Cancer and precautionary measures to be taken into consideration in order to avoid and protect from the disease. He quoted that 'Prevention is better than cure', by emphasizing healthy food, habits and exercise are necessary to improve standard of living. Principal, Shri S.R. Patil, presided over the function wherein all the teaching and non-teaching staff, students were present.
