Standing Operating Procedure for Anti Ragging Cell

➤ Objectives:

The college has constituted the Anti-Ragging Cell in order to ensure comfortable environment for the studying in the campus of the Institution. It is a Supervisory and Advisory Cell which prevents ragging in the College Campus. Our College believes in fostering a harmonious relationship amongst its students and strictly condemns ragging.

➤ Structure

The committee shall consist of Principal as a Chairman, faculty members as Co-ordinator and Members of Committee and students as a Student Members. It shall serve for the period of Three years.

➤ SOP:

1. Awareness is created via orientation programme in the first semester as well as before the commencement of each academic year.
2. The Ragging covers following acts
 - Any act of Indiscipline, Teasing or Handling with Rudeness.
 - Any act that Prevents, Disrupts the Regular Academic Activity.
 - Any activity which is likely to cause Annoyance, hardship, Psychological Harm or creates Fear or Apprehension.
 - Any Act of Financial Extortion or Forceful Expenditure.
 - Any Act of Physical Abuse causing Assault, Harm or danger to Health.
 - Any Act of abuse by spoken words, emails, SMS or public insult etc.
 - Any Act of injury or infringement of the fundamental right to the human dignity.
 - Any Act of Wrongful Confinement, Kidnapping, molesting or committing unnatural offences, use of criminal forces, trespass or intimidation.
 - Any unlawful assembly or conspiracy to ragging.

 - Suspension from attending classes and academic privileges
 - Withdrawing scholarships and other benefits
 - Suspension from the college
 - Cancellation of the admission
4. Monitor anti – ragging activities in the Institution
5. The whole campus is under CCTV surveillance and the movements of the students are monitored
6. The committee shall hold the meeting at least once in a year.
7. It may also convey the meeting at the time of need.
